This office will <u>NOT</u> accept mailed applications. You must send applications electronically. <u>Failure to submit all required documents as outlined below will result in your application not being considered for employment.</u>

### **AGR REQUIRED DOCUMENTS:**

- 1.) NGB 34-1 (*dated Nov 2013*) Application for AGR Position. <a href="http://www.ngbpdc.ngb.army.mil/forms.htm">http://www.ngbpdc.ngb.army.mil/forms.htm</a>
- 2.) Copies of the last five OPRs (Officers only).
- 3.) Resume (any format).
- 4.) 3 References on a separate sheet of paper with email address and additional point of contact number(s).
- 5.) Individual Personnel (RIP) from vMPF only (must be dated within 60 days).
- 6.) Current Fitness Test from AFFMS II (*Per AFI 36-2905 current within 12 months*).
- 7.) Security Clearance verification memorandum (*Do not submit a JPAS print out*).
- 8.) Letter(s) of recommendation (optional).

\*All documents must be consolidated into a single pdf. File. DO NOT put in PDF Portfolio format. Send applications in the following format: MVA number, Rank, last name, First name, Middle Initial. Ex: 18-100 – SSGT DOE, JOHN A \*Any documents with SSN must have the SSN redacted (Blacked-out).

### **Conditions of Employment:**

<u>National Guard Membership:</u> Prior to appointment to this position, selectee must be a member of the District of Columbia Air National Guard.

Electronic Funds Transfer: Selectee is required to participate in electronic funds transfer/direct deposit.

If applying for an MVA at a lower rank, a voluntary demotion memorandum stating action must be submitted.

**Evaluation Process:** Applicants will be evaluated solely on information supplied in application documents outlined above. Interview responses will also be considered when applicable. Incomplete applications will not be considered. It is the responsibility of the applicant to contact the POC identified on this vacancy announcement prior to the vacancy closing date to verify all documents have been received. Failure to do so may result in in disqualification. Complete and accurate data is essential to ensure fair evaluation of candidates.

**Announcement Number:** 18-385

**Position:** Aircraft Ordnance Sys Mech (Egress)

**Brief Description of Duties:** Maintains aircraft egress systems with ejection seats, canopies, and hatches; explosive components; electro-explosive devices (EED); subsystems; and related support equipment (SE). Advises on and solves installation, maintenance, and repair problems by studying schematic and technical publications. Diagnoses malfunctions and recommends corrective action. Implements maintenance and safety policies for egress systems and integral egress system components to include personnel parachute assemblies and survival kits. Performs scheduled and unscheduled maintenance on egress systems. Removes, installs, and modifies egress systems. Ensures egress explosive cartridge activated devices (CAD), pressure activated devices (PAD), and EEDS are safe or de-armed prior to performing maintenance. Performs operational and functional tests of egress systems, subsystems, and components using test equipment and test kits. Applies corrosion control procedures to escape systems and related components. Operates and maintains related SE. Uses maintenance information systems (MIS) to monitor maintenance trends, analyze equipment requirements, and maintain equipment records, document maintenance actions, and time change database. Performs integrity inspections of the escape system. Inspects egress systems, subsystems, and components for safety, security, and serviceability. Inspects and determines serviceability of CAD, PAD and EED devices based on shelf and service life limits. Handles, labels, and disposes of hazardous waste and materials according to federal and local environmental standards. Performs other duties as assigned.

### **Qualifications:**

- 1. Must be able to retain a SECRET security clearance.
- 2. Must Be AFSC Qualified. AFSC: 2A6X3

### **Eligibility Requirements:**

- 1. Applicants who have been separated for cause from active duty or a previous AGR tour are ineligible.
- 2. Prior to entry into the AGR Program, member must be medically cleared by the 113th MDG.
- 3. Must meet all eligibility requirements in accordance with ANGI 36-101.
