**Position:** WING INSPECTOR GENERAL / CHIEF OF INVESTIGATIONS BRANCH (WG/IGQ)

\*\*\* This is a Drill-Status position. Incumbent will be guaranteed 1 weekend/month and 15 additional days. \*\*\*

**Brief Description of Duties:** All duties are IAW AFI 90-301. Manages and executes the Air Force IG Complaints Resolution and Fraud/Waste/Abuse programs for non-senior official personnel at the Wing level. Takes complaints from all Wing members and determines best course of action for resolution IAW Air Force and ANG regulations. Answers all higher-headquarters and State IG taskings. Provides progress reports, interim reports, and periodic updates. Coordinates with EO, JA, DPH, SARC through the IDS/CAIB process to keep the Wing Commander informed of workplace climate.

Incumbent is provided a private office in the Wing Building and reports directly to WG/CC. Incumbent will be placed in a UTC-based position that may require deployment, so all deployment qualifications are expected to be maintained.

Work weekends (UTA) will be scheduled prior to the year of execution and incumbent will be provided this schedule to assist in future planning. Deviations from scheduled weekends are acceptable with supervisor approval.

Air Force IG Course attendance will be required for award of 87Q0 AFSC. Course is 5 days in length.
